| 1 | When is the deadline for submitting the proposal. | The deadline is March 03 and there is no room for flexibility. |
| 2 | Is it a must to apply for all kinds of non-chemical fertilizer production/distribution? | No, it's not. Potential applicants can submit proposal on one of the listed non-chemical fertilizer types or any other kind. The main objective for MS4G is accessibility and marketability of the product. |
| 3 | What is meant by secondary city? Please clarify. | Secondary city is a city with a population of greater than 100,000, inclusive of surrounding and nearby towns. |
| 4 | Is it possible to apply as consortium PLC, Universities and NGO? | MS4G will only sign agreement with one lead organization, but that organization may form a consortium with plc and NGOs/CSOs or private actor on behalf of universities and other government stakeholders. MS4G will not provide direct grant to government or government structures. |
| 5 | What is the budget ceiling per a submission | We have allocated USD 1M for five awardees (average USD 200,000 each). |
| 6 | What is the age limit for youth and women? | The age we consider as youth is from 18-29 but considering the complexity of non-chemical fertilizer production MS4G is flexible to accept up to 35. |

| 20 | What are the modalities of finance transaction? Reimbursement or another scheme? | MS4G will negotiate pre-determined milestones and means of verification. Payment will be made upon successful completion of the milestones. No advance payment is allowed. Payments are made in ETB. |
