Should this report be written as narrative description in the application-technical proposal, or it should be sent as a (report) separate documents to you together with the technical proposal?	We have removed this requirement from the technical proposal.
2	references as a document issued and signed by 3 companies?	Only submit contact details of references.
3	table.	Electronic proposals must be submitted by sending two separate emails, one for technical proposal and one for cost proposal with the RFP number in the subject lines.

The lead organization should fulfill all requirements. Registered entity must be registered in W Balkans, for the other entities it is up to the consortium.

10	For the budget format, do applicants have to create it ourselves or will you start a form?	We can provide a budget template, however, it is not required. Each applicant may use their own budget template, if preferred, if it meets the requirements outlined in the RFP.
11	Should the accompanying documents of the application be included in the technical proposal email?	Anything that is not a part of the budget/cost proposal should be included in the technical proposal.
