Palladium is a global leader in the design, development and delivery of positive impact — the intentional creation of enduring social and economic value. We work with corporations, governments, foundations, investors, communities and civil society to formulate strategies and implement solutions that generate lasting social, environmental and financial benefits.

Project Background

The CATALYZE Blended Finance Mechanism is a \$250 million, 8-year contract (5-year base period, with a single 3 year option period) which uses a facilitated partnership model to craft solutions to crowd in \$2 billion in blended finance (i.e. blended concessional and commercial finance) to USAID partner countries and initiatives. CATALYZE allows USAID Bureaus and Missions to efficiently deploy investment facilitation solutions that respond to the needs of specific sectors, issues, and geographies. Initial programs focus on education finance to implement sustainable education business models serving low-income communities, and achievement of women's economic empowerment objectives, but the mechanism can be applied to any development challenge or region.

Within CATALYZE, the Early Childhood Care and Education (ECCE) Activity aims to facilitate access to high-quality ECCE in order to unlock improved learning and development outcomes amongst children and improved livelihood outcomes for women. Women's livelihood outcomes encompass: (i) advancement (entry into formal work, labor force pivots); (ii) intrahousehold impacts (bargaining power, intimate partner violence, and time use); and (iii) well-being (mental and physical).

In Paraguay, CATALYZE ECCE aims to provide additional services to select households with a child/children enrolled in ECCE centers receiving CATALYZE ECCE support. As we define the scope of services, CATALYZE ECCE aims to better understand the landscape for both vocational service provision and gender norms training in the country.
